Demonstrate how interests, knowledge, and skills relate to personal choices and intent when creating, performing, and responding to music.</p>	<p><b>Sample Guitar 1 Lesson Plan for Marking Period 3</b></p> <p><b>Class: Guitar 1 - 40 minutes</b></p> <p><b>Suggested Activities:</b></p> <p><b><u>Perform a piece of music for solo guitar with two voices</u></b></p> <ul style="list-style-type: none"> <li>• Introduce and demonstrate how a piece of solo guitar music can contain two separate voices - melody/bass. (10 minutes)</li> <li>• Students will learn and practice “Study for Two Voices” (30 minutes)             <ul style="list-style-type: none"> <li>• Identify voice 1 - melody and voice 2 - bass line</li> <li>• Learn and practice each voice individually.</li> <li>• Perform voices as a 2 part ensemble.</li> <li>• Students will practice playing both voices at the same time paying close attention to L.H. and R. H. fingering.</li> </ul> </li> <li>• Students will continue to practice and refine over a two week period, then perform for an assessment.</li> </ul> <p><b><u>Performing legato/staccato</u></b></p> <ul style="list-style-type: none"> <li>• Introduce “Waltz” by Czerny. Identify legato and staccato markings and demonstrate their execution. (5 minutes)</li> <li>• Allow students time to experiment with playing notes both staccato and legato. (5 minutes)</li> <li>• Learn both parts of Waltz, focusing first on notes and fingerings. (20 minutes)</li> </ul>

Break assignments up into shorter tasks while repeating directions as needed. Offer additional individual instruction time as needed.</li> <li>• Modify test content and/or format, allowing students additional time and preferential seating as needed, according to their IEP or 504 plan. Review, restate and repeat directions during any formal or informal assessments.</li> </ul>	<ul style="list-style-type: none"> <li>• Provide extended time to complete classwork and assessments as needed.
