**BAYONNE BOARD OF EDUCATION ELECTION**

The election for members of the Bayonne Board of Education will be held on **Tuesday, November 8<sup>th</sup>, 2022**.

The deadline for filing to seek a seat on the nine (9) member board is **Monday, July 25<sup>th</sup>, 2022** at 4:00p.m.

Nominating Petitions are available from the Office of the Hudson County Clerk – Elections Division is open between 8:30 a.m. and 4:30 p.m. and is located at 257 Cornelison Avenue - 4<sup>th</sup> Floor, Jersey City, NJ 07302. The contact number is 201-369-3470 extension 2767 or option 6.

**Completed nominating petitions must be submitted in person and must be received by 4:00pm on July 25<sup>th</sup>, 2022.**

There are **four (4)** seats available:

- Three (3) seats available each for a term of three (3) years which will be voted upon  
The terms of Lisa Burke, Jan Patrick Egan & Denis Wilbeck are expiring.
- One (1) seat available each for a term of one (1) year which will be voted upon  
The term of Hector Gonzalez, Jr. is expiring.

Candidates filing a nominating petition for Board membership must meet the following qualifications:

- He/she is a citizen of the United States of America
- He/she must be at least eighteen (18) years of age to qualify for office
- He/she must be able to read and write
- He/she has been a resident of the municipality from which he/she is to be elected for at least one (1) year preceding the date of the election
- He/she is not disqualified as a voter pursuant to N.J.S.A. 19:4-1
- He/she is a registered voter in the district
- Not hold office as a mayor or member of the governing body of the same district
- He/she is not disqualified from membership on the Board due to conviction of a crime or offense listed in N.J.S.A. 18A:12-1
- He/she has no interest in any contract with, or claim against, the Board
