All statements and/or questions shall be directed to the presiding officer and no participant may address or question Board members individually. All speakers are

requested to express themselves in a civil manner, Please note: While it is not the Board's intention to stifle comment on matters of legitimate concern to the their statements violate the rights of others under the law governing defamation or invasion of privacy, they may face personal liability to the injured party.

If speakers are uncertain of the legal ramifications of their comments, the Board urges them to seek guidance beforehand from their own legal advisor.
