**WHEREAS**, the Bayonne Board of Education has set educational goals in accordance with the State of New Jersey; and

<u>WHEREAS</u>, the district-level goals, along with the district's strategic plan, help guide resource allocation and identify areas of focus in the district's planning efforts; and

<u>WHEREAS</u>, throughout the year, the district reports out on the progress toward achieving adopted goals and toward accomplishing the strategic plan objectives; and

<u>WHEREAS</u>, district-level goals are carefully considered and established each year, and it ensures everyone is familiar with the direction being set and has participated in setting that direction for the benefit of our students; and

<u>WHEREAS</u> it is understood that the mission of the Bayonne Board of Education is to serve the community by providing quality education for our students, through the adoption of the following district goals for the **2023-2024** school year:

## Background:

NJ Legislature has a bill pending that would eliminate the use of the discrepancy formula for identification of Specific Learning Disability (SLD).

State criteria for determining whether a student has a specific learning disability shall:

- Prohibit the use of a severe discrepancy between intellectual ability and achievement for determining whether a student has a specific learning disability.
- Permit process based on student's response to scientific, research-based interventions (RTI)
- Permit the use of alternative research-based procedures, including but not limited to, Patterns of Strengths and Weaknesses (PSW) or case studies

Tiers of support need to be well-defined, research-based & implemented with fidelity.

Administrators and teachers will require professional development on the new law and it's implementation. Bayonne School District Multiple Tiered System of Support (MTSS) Teams will require additional training to identify PSW. Child Study Teams (CSTs) will need additional training to analyze test results in a different way.

## GOAL #1

	Moving away from the severe discrepancy approach will require educators to learn new skills and implement a framework of tiered supports in general education and assessments to inform decision-making. This type of system change needs to be paired with technical assistance, coaching, and tools and resources to support implementation
