A budget may need to be modified as an individual's career, financial goals

(e.g., education, home ownership, retirement), and/or other life situations change.

Money management requires understanding of cash flow systems and business practices.

A person's tolerance for investment risk can change depending on factors such as life circumstances, financial goals, and economic conditions. Different types of insurance have different costs and protections. There are strategies to improve one's professional value and marketability. Career planning requires purposeful planning based on research, self-knowledge, and informed choices. An individual's income and benefit needs and financial plan can change over time.

Securing an income involves an understanding of the costs and time in preparing for a career field, interview and negotiation skills, job searches, resume development, prior experience, and vesting and retirement plans.

Understanding income involves an analysis of payroll taxes, deductions and earned benefits.

There are ways to assess a business's feasibility and risk and to align it with an individual's financial goals. With a growth mindset, failure is an important part of success. Innovative ideas or innovation can lead to career opportunities.


